WHEREAS, A General Municipal Election was held on Tuesday, November 2, 2010, for the election of certain officers as required by the provisions of the laws of the State of California; and

WHEREAS, this is the time and place specified by law for the Council to meet and proceed to canvas the votes cast at said election.

NOW, THEREFORE, BE IT RESOLVED, BY THE City Council of the City of Del Rey Oaks that it is found and determined:

1. That the total number of votes cast at said election was 717 and that the following persons received the number of votes for the following offices:

- a) For the Office of Mayor, Two-Year Term:

That the person receiving the highest number of votes cast at said election for the Office of Mayor was Jerry B. Edelen, and is hereby declared to be elected to said office for a two (2) year term.

Dennis Allion	477 (67%)

That two persons receiving the highest number of votes cast at said election for the four (4) year term office of City Council Members were: Jeff Cecilio and Dennis Allion and said persons are hereby declared to be elected for a four (4) year term to said office.
