A MESSAGE FROM MAYOR EDELEN



The economic future of the City of Del Rey Oaks is looking brighter than it has in many years.

On June 2nd, our attorneys will be in court defending against our prior developer, Federal Development LLC's cross complaint alleging they hold a financial interest in our Fort Ord property. We have the law and the legal arguments on our side and we expect a quick resolution in our favor.

Your City Council has approved our City Manager, Mr. Dan Dawson to negotiate with Topes Sustainable Garden Center as to when and how they will relocate to our old Golf Driving Range. This could prove to be an ideal partnership...a sustainable business relocating to and upgrading our quickly dilapidating Golf Driving Range and by doing so, bringing in additional revenue to our city.

We are also in negotiation with Monterey Peninsula Partners to do some initial development on our 360 acre parcel on the old Fort Ord. Some of the projects being explored are a 2 megawatt solar farm and an upscale Recreational Vehicle Facility which would be located on the far eastern edge of our property close to Laguna Seca.

With these projects and others, we can expect to bring in a significant amount of revenue which we will use a portion of to pay off a substantial debt our former developer incurred, refuses to pay, and now the city is liable.

Before any project is approved, the project will be agendized, advertised and brought before your City Council for discussion. As always, you will have ample opportunity to provide your City Council with your thoughts with regard to all potential Del Rey Oaks developments.

Our city continues to employ a lean, professional staff and city government, a balanced budget, and an excellent cooperative working environment. And, our city is also in better financial shape than most of the cities in Monterey County.

Finally, our water situation.... Over two years ago, the State Water Resources Control Board declared that CAL-AM was illegally pumping water from the Carmel River and that the pumping had to stop and the water replaced by January, 2017. The six mayors of the Monterey Peninsula, seeing that nothing was being done by the Water Management District to

avert a fiscal and water calamity, got together and formed the Mayor's Joint Powers Authority; later, renamed the Monterey Peninsula Regional Water Authority (MPRWA). Quickly realizing the only realistic way of providing the volume of water needed was to build a Desalination Plant, the MPRWA requested proposals from any firms that wanted to be considered to build the Desalination Plant. Three groups submitted proposals: Deep Water Desal, the People's Project, and CAL-AM. All three proposals were thoroughly evaluated by an outside firm contracted by MPRWA and CAL-AM's proposal was determined to have the highest probability of success at the lowest cost. Thus, CAL-AM was selected and has been working as quickly as possible to build the plant. The problem is that with the California Environmental Quality Act (CEQA) and Environmental Impact Report (EIR) requirements, the Desalination Plant will not be completed by January, 2017; but, will be completed sometime later in the year. I and the other mayors in the MPRWA are convinced that if and only if all of the major water players on the Monterey Peninsula remain united and continue to work together, the State Water Resources Control Board will not implement their draconian Cease and Desist Order (CDO) which would result in severe water rationing; but, will give us a conditional extension of the deadline until the Desalination Plant is completed. I will continue to work on our city's behalf towards that end.

I thank you for your continued support, and as always, it is an honor for me to serve as your Mayor and to continue to try to improve the city that we all love.

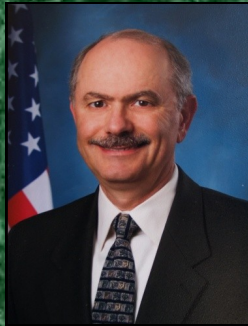

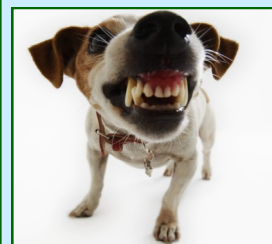

Dog Park Basics!

1. **DO NOT** let your dog off leash outside the designated Dog Park fenced in area! It is a violation of the municipal code and you can and will be cited if caught.
2. Remember: **If your dog poops you must scoop, even if no one is looking!**
3. If your dog is not vaccinated or is not feeling well they are not aloud in the dog park
 4. If your dog digs a hole fill it!
 5. If your dog cannot get along with other dogs they are not aloud in the dog park.

A Message from your City Manager Daniel Dawson

Despite the continuing efforts to bring in Revenue to our City and the bright potential prospects on the horizon our City remains in debt to the tune of \$1,000,000 plus!

A lawsuit with the former Fort Ord Developer has been an ongoing money drain for the past 4 years and has yet to reach a conclusion, legal expenses to date have totaled in excess of \$400,000!

The City does not have nor have we ever had either a Reserve Account or a “Rainy Day Fund” nor a Capital Improvement Program Budget to replace aging streets, city equipment and buildings. We are truly on a shoestring budget with an emaciated skeleton crew here in Del Rey Oaks. The City provides services on an Annual Budget of \$1.9M and has a full time staff of 10 employees. Contrast this with the slightly larger City of Carmel which has an Annual Budget of \$18M with a staff of 85 employees! We are truly a model for doing more with less. We have the lowest pay, the lowest Retirement Plan allowances and conversely we have the highest morale! How can this be, you ask? It goes to show that money doesn’t buy happiness, we treat each other with dignity and respect and don’t have the extra time to bicker and play political games because we are all focused on the goal of preserving the very City we love here in Del Rey Oaks!

On the other hand, happy employees and a unified group of political leaders doesn’t pay the bills and with only very limited Sales Tax Revenue sources, income from Property Taxes of 6 cents for every property tax dollar you pay coming into City coffers we are always behind the funding curve without new sources of revenue!

Topes Sustainable Garden Center is working with us to Lease a major portion of the old driving range and once they wind their way through the Planning Commission and City Council approvals we anticipate an aesthetically pleasing project with hundreds of thousands of dollars in improvements and the ability to gather both Sales Tax and Lease Revenue from the 1-2 employee operation.

Monterey Peninsula Partners is a group of locals headed by Mr. Brad Slama, the man who first brought a Recreational Vehicle Park proposal forward awhile ago, the message he got from the handful of residents that spoke out at City Council meetings that the idea was great but the choice in location (the old Driving Range) was terrible. He took this feedback

seriously and has worked with the City to see if the RV Park idea was a possibility for our Fort Ord property on South Boundary Road. Partnering with a financier he is currently seeking to purchase the entire 360 acre site in phases with the initial phase being 50 acres on the Eastern boundary where he would construct the RV Park and a 20 acre site on the Westerly end of the property to be proposed for commercial development in conformance with the Fort Ord Base Reuse Plan. Negotiations are ongoing and there may be other opportunities associated with the site to bring some much needed revenue to the City so that we can provide the Public Services and infrastructure that you so deserve.

Safeway has not ever submitted a formal application for a Gas Station behind the existing store and with ownership changes at the Corporate level they may or may not wish to do so. Our job as City Staff is to allow a fair and impartial process to ANY applicant along with the appropriate level of Public Participation. The City Council is very cognizant of the fact that they represent all 1700 residents of the City and not just the 5-6 with signs in their yards.

Public input into continued operation of the Dog Park is being solicited via a task force headed by Citizen Frank Lucido and the City Council has directed Staff to bring a Fee schedule back for approval so that the Dog Park pays some expenses of operation. I recently visited "Dog Bone Meadow" in the City of Novato and was impressed with the amenities and quality of that spacious Dog Park which is completely funded and operated by a Volunteer group of Dog loving citizens at no cost to the City.

Emergency Communications costs for our Police Department provided by the County 911 Dispatch Center continue to increase, Storm Water Permit costs were increased 500% despite my adamant protests. Sales Taxes are up slightly from last year and Property Taxes remain fairly flat. We lost Jamba Juice and The UPS Store as Sales Tax producers this year to be replaced in the Stone Creek Center by a Dentist Office and an expanded Emergency Veterinary Clinic, both non-tax revenue producers. I am in the process of negotiating a new Garbage Hauling Franchise Agreement with Green Waste Recovery which will take effect in 2015 and run for 15 years. All of the Monterey Peninsula Cities are negotiating with Green Waste who was the most responsive to a proposal sent to several waste hauling companies, including our current hauler Waste Management.

The City of Del Rey Oaks continues to be an attractive, clean and safe City with quality employees and quality residents. The quality that you want to see in the future will depend greatly on our ability to continue to manage scarce resources efficiently and to attract and retain economic activity that pays for the services you all want and deserve.

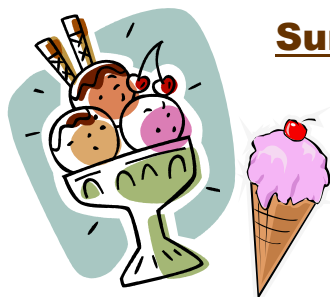

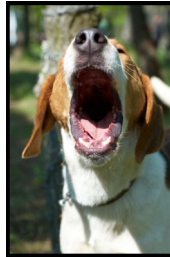

My neighbor's dog never stops barking!



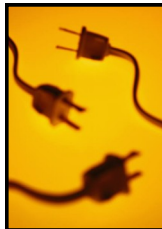

Do I need a permit to trim or cut down a tree?



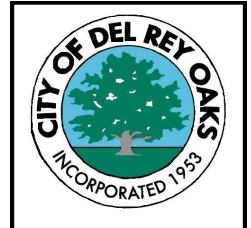
Any tree/branch larger than 6" across requires a tree permit. If you are considering trimming or cutting down an oak tree an arborist report is required showing need for removal before a permit can be issued. All permits cost \$25.

New water heater, upgrading electrical panel, moving a socket, sewer work, plumbing issues?



All these things and more require a permit prior to beginning work. If you're not sure about it give city hall a call at 394-8511, we'll guide you through the process. Why Nixle?

Founded in 2007, Nixle now works with over 4600 public safety agencies across the US to ensure you get the vital information you need, when you need it.

How does it work?

By simply sending a text message with your zip code to 888777, you are instantly registered to receive text messages from local public safety agencies in your area. Want more control? Create a Nixle account at www.nixle.com and tailor exactly what information you receive and how you want to receive it - via text message, email, mobile application, or web browser.

Can I trust it?

Unlike social media networks such as Twitter and Facebook, Nixle employs a thorough screening process to verify that every agency joining the Nixle service is authentic. Other security measures such as 2-step login verification help to safeguard agency accounts beyond the level of protection provided by other online services. All of this is done to ensure that the messages you receive from Nixle are genuine and reliable.

What else does Nixle provide?

Nixle is not only for emergencies. Stay up to date on other information affecting your community including traffic alerts, safety tips, and local crime information with your Nixle account. Messages always include a priority level so you can immediately judge their urgency upon receipt. Nixle also gives you the flexibility to direct messages based on priority so you can receive urgent information via text message and the rest via email.



what is nixle?

Founded in 2007, Nixle is a communication system that connects residents with the agencies that serve and protect them. Residents can use Nixle to receive information ranging from critical alerts to community news. Additionally, residents can choose how they receive this information - by SMS (text message), email, over the Web or by mobile application.

how does it work?



Message Publishing

Your police department and other local municipal agencies use Nixle as a publishing system. Messages are created and assigned a priority level ensuring important information reaches you in a timely manner.

Location Targeting

Messages are targeted to specific geographic regions. If your address falls within this geographic area, you'll receive the message. Add as many locations as you'd like from across the country.

Receiving Messages

Enter your mobile phone number to receive messages by SMS (text message). You can also choose to receive emails, or simply view the messages by logging into your Nixle account. You decide!

Storm Water

The City of Del Rey Oaks is a permitted member of the Monterey Regional Storm Water Management Program (MRSWMP).








One of the regional storm water permit program responsibilities is to properly manage urban runoff and storm water that drains into the Monterey Bay via the storm drain system, and to prevent pollutants entering the storm drain system (oil, carpet cleaning wastewater, auto detailing soaps and rinse water, restaurant mat and trash area wash down, pesticides/fertilizers from landscapes, etc).

ALL storm drains flow directly to either the Monterey Bay or other water bodies throughout the area; they do not go through a treatment process prior to draining to the sea water bodies. Only rain should go into storm drains.

Del Rey Oaks is also responsible for implementation of the City's annual storm water program, with assistance from our regional program manager, and compliance with the State's storm water regulations utilizing best management practices (BMPs) to meet measurable goals outlined in our adopted storm water plan.

You as our residents have a crucial role in our Storm Water Program. These include:

-  Report any foreign liquids or solids you see in the City gutters or streets, or entering the storm drain system to the Police Department at 831-375-8525. Some examples would be paint, fuel, concrete wash off, sewage & debris, including litter, etc. Also report anyone you see dumping fluids or sweeping lawn debris/leaves into storm drains.
-  If you see any liquid coming out of a manhole, report it immediately to the Police Department.
-  Please keep the gutter in front of your home free of leaves, pine needles and other debris, minimize the usage of pesticides or fertilizers, and minimize lawn irrigation to prevent runoff and water waste.
-  Do not change the oil or other fluids of your vehicle in the street and ensure your car does not leak oil onto the street (if parked on the street)
-  Move your vehicle out of the street on street sweeping days (Usually the first Wednesday of each Month).
