A MESSAGE FROM MAYOR EDELEN



Del Rey Oaks is truly entering a golden age. We've finally been able to diversify our revenue sources, and our revenues are increasing significantly.

With these additional revenues, we can now begin addressing our city's aging infrastructure.

In a couple of months, we will begin slurry sealing and repairing our streets. This has not been done for almost two decades due to budget limitations. Next year, we will continue the process.

There are also several renewable energy initiatives that your City Council is starting:

1. Our entire City has switched over to PG&E's "Solar Choice". That means all power used by our city is produced by solar power. If being energy efficient and reducing your carbon footprint is important to you, you may wish to contact PG&E and ask that your home account also be switched to Solar Choice. It costs just a bit more; but, all electricity sold through this program is from renewable solar energy generation.
2. We are going through the process of installing solar panels on city hall. Once installed, we expect to realize significant annual savings on our city's power bill. Both I and your Vice Mayor, Kristin Clark have installed solar panels on our homes with very significant savings on our electricity bills each month. And, there are firms locally that will install solar panels on your home for a very reasonable cost.
3. On Saturday, June 16th we will be holding an "Energy Fair" at our Park. We will be inviting Energy Experts to set up information booths where you can discuss your energy needs to see if you can also realize monthly reductions in your energy bills. We expect Solar Power Installation Companies, Contractors that install Instant-on hot water heaters, Home Insulation Companies, and Thermal Window Installation Companies to be present. In addition, a representative from the Association of Monterey Bay Area Governments (AMBAG) stated that she would also be present to help promote energy efficiency.

Please be sure to stay informed about the exciting initiatives our city is working on. And, as always, we welcome your ideas. Our City Manager, Dino Pick, outlines a few of these initiatives in his message in this Acorn. To keep updated:

1. Please visit the Kiosks we have erected in our city at the intersection of Quendale/ Portola; on Rosita/ Angelus; Via Verde (above the park) and outside the main entrance of City Hall.
2. You should also periodically check our City Website: www.delreyoaks.org. At the website, you will find videos of our City Council Meeting, agendas for upcoming meetings, our Municipal Code and other important information.
3. Download the Del Rey Oaks Application to your Smart Phone. It will keep you updated on real time information about city emergencies. There is an information brochure at City Hall as to how to do this.
4. Call City Hall and ask to be put on the automatic mailing list to receive our City Council Agendas each month.
5. And, lastly, please take some time out from your busy lives to attend our City Council Meetings and other important city events such as our City Picnic, Holiday Party, Ice Cream Social, City-Wide Garage Sale, and other events. This is your city. We strive to constantly improve it.

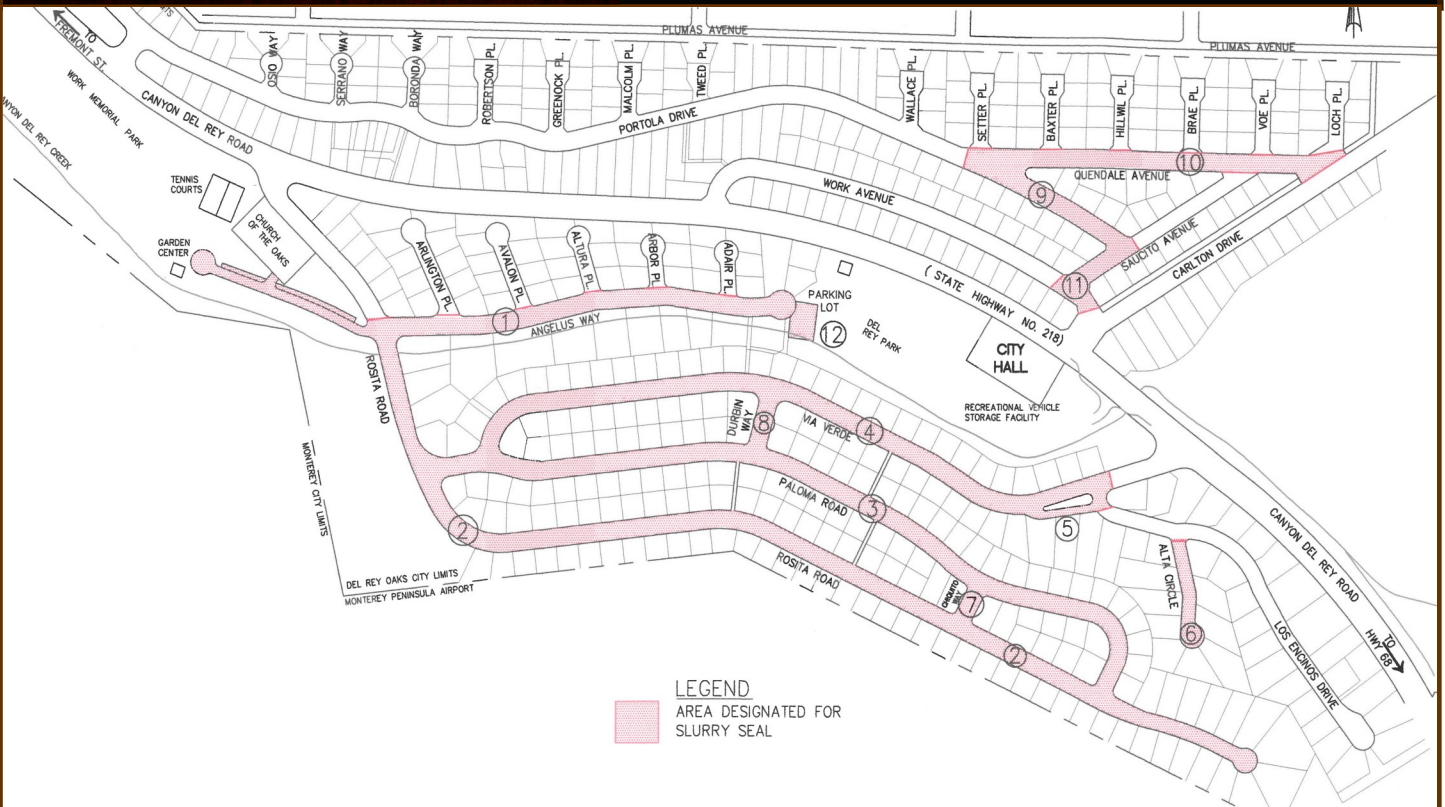

As part of the 2017/2018 Budget the Council approved a capital improvement project to slurry seal streets in Del Rey Oaks. The criteria for which streets were chosen was based on their current condition. The streets in the worst condition were too expensive to do this time and are planned for the 2018/2019 budget year. If your street is shown in red you will see several projects leading up to the actual slurry sealing that will happen in June of this year. Tree roots are being dug up and the street repaired before the sealing process can begin.

The week of June 4th Bond Blacktop will be taking off all the existing striping and filling any large cracks in the road. The week of June 11th they will do the actual slurry sealing, and the week of June 18th they will restripe the roads. We will be asking you to keep your cars off the streets at certain times and will notify you ahead of time when this needs to be done. Thank you in advance for helping us improve the city one street at a time.



A Message from City Manager Dino Pick

I have had the honor of serving as your City Manager for one year as of March 27 and what a year it has been! I would like to give you an update on the many exciting initiatives underway in our City. First, our Police Department, under the leadership of Chief Hoyne, has properly disposed of older fleet vehicles, including the Mine Resistant Armored Personnel (MRAP) vehicle, and added two new Ford Explorer Police patrol vehicles paid for with grant funding from the Fort Ord Reuse Authority (FORA). Our vehicles are uniformly marked, and well maintained. Under Chief Hoyne's leadership our collaboration with the Airport District Police has already provided us with more depth in our police department and the service we are able to provide our City. I expect this collaboration to grow and offer us increased capabilities and efficiencies as we look at combining departments then providing contract police services to the Airport.

The Transportation Authority of Monterey County (TAMC) is overseeing a Highway 218 Corridor Study with the Cities of Del Rey Oaks and Seaside. This \$150,000 study analyzes vehicle, bicycle and pedestrian safety along 218 from Hwy 68 to Hwy 1. TAMC held a kick-off meeting at Del Rey Oaks on January 25, 2018, which included CALTRANS, TAMC, Kimley-Horn (the same traffic engineer working on our traffic calming) and City staffs. Public outreach began with a presentation to City Council on February 27, 2018. A bus/walking tour of the corridor took place April 7th where the public discussed various concerns with staff. If you have not yet, please provide your input online at <http://www.tamcmonterey.org/programs/highway-projects/218-study/>. The goal of the project is to produce project concepts that can compete for grant funding to make 218 safer for pedestrians, bicycles and vehicles.

The Fort Ord Recreational Trail and Greenway (FORTAG) is an exciting TAMC regional trail project funded by \$20 million dollars of Measure X revenue over 30 years. City staff met with TAMC and several key planners/stakeholders on February 8, 2018 to discuss the environmental review process, public engagement, and phasing of the project. Dr. Fred Watson presented to the public at the March City Council meeting. TAMC is moving forward with the environmental review process.

The City is considering developing the 17 acre City-owned parcel located at the intersection of General Jim Moore Boulevard and Hwy 218, across General Jim Moore from the Frog Pond. The City received an unsolicited proposal to purchase the parcel for development in accordance with its General Plan zoning, which is Neighborhood Commercial with Visitor Overlay. At the October City Council meeting Council directed staff to market the property for development proposals and return to Council. The City received two development proposals and held a Special Council meeting March 13th to hear presentations by the developers and receive public comment. Council held a closed session meeting on March 27th to provide staff confidential negotiating guidance. The Regional Parks District has expressed interested in acquiring portions of the 17 acre parcel. Staff will return to Council in April or May with recommendations. City Council may direct staff to move forward with a developer, preserve portions of it for parkland, or as environmental mitigation for development elsewhere, or choose not to develop at this time. If a developer is selected there will be a public process that will involve public outreach, City Council and Planning Commission public hearings to review and approve any development.

Council approved \$100,000 for traffic calming projects on Carlton and Portola/Quendale in the 2017-2018 budget. Following public workshops on August 14, November 2, and January 9, Council voted on January 23, 2018 to direct staff to install four radar speed signs on Portola Avenue, similar to those on Carlton. The signs were delivered in early-March. Staff spoke with residents concerning precise placement. Poles were placed on the proposed locations for one week prior to installation. The signs were installed in late March. Council also directed staff to assess the feasibility and conducting environmental review of limiting traffic at Carlton near Plumas to pedestrians, bicycles, public safety and mass transit vehicles. Staff conducted traffic counts in mid-February. Staff placed temporary message signs for one week prior to a temporary closure from April 2-27 during which time staff conducted the second round of traffic counts. We are continuing coordination with the City of Seaside, residents, public safety and MST/MPUSD to complete the feasibility assessment and environmental review by May 2018. Should the assessment and environmental review allow for the project, staff will design and bid the contract with the intention of presenting it to Council with the findings in May or June 2018. TAMC submitted a grant application for FY 2018-2019 to support design and construction of a bike/pedestrian path along Carlton. This project may allow improvement to stormwater drainage on Highland and potential lane reconfiguration of Carlton. Council also directed staff to redesign the intersection of Work and Carlton and return for approval.

We are going to pave many of our streets in June! Council approved \$175,000 for street resurfacing in the 2017-2018 budget. The City Engineer assessed the Pavement Condition Index of City streets in October 2017 and presented a package of streets for resurfacing to Council at the November City Council meeting. Council approved the engineer/data driven street selection. Staff opened bids on February 8, 2018 and Council awarded a contract on February 27, 2018. Preparatory patching work is underway and we look forward to paving streets in June 2018.

Council directed staff to prepare a Short Term Rental (STR) Ordinance. Staff held a community workshop on April 5th to discuss options including status quo, banning STRs, or regulating them within the City limits. The workshop was very well attended with constructive public input. Staff will brief City Council at the April 24th meeting.

The City continues to lead in energy Conservation. The City enrolled in PG&E's Solar Choice program so 100% of our power consumption for City buildings and the RV Park is from solar power. Staff continues to develop options to place solar panels on City Hall to reduce our need for PG&E provided solar, this will reduce the City's power bill while continuing to maximize our use of renewable energy. Staff continues to plan a solar open house for June to promote energy efficient upgrades to residential and commercial properties within the City. Finally, Staff conducted an initial feasibility study concerning the potential formation of a Del Rey Oaks Community Choice Aggregation (CCA) program to give our residents an alternative to PG&E. There is the potential for us to form a CCA that limits liability exposure, provides residents competitive power rates, and provides the City with a very small revenue stream that can be used as Council sees fit. Based on this initial feasibility study, staff prepared a request for proposals and will bring the results to Council for public discussion including comparison with Monterey Bay Community Power as soon as ready.

Our Public Works staff have been working diligently to keep our park, trails, and stairway easements clear and looking good for the enjoyment of our residents and visitors. This includes beautifying our entry way signs with flowers donated by Del Rey Oaks Garden Center. We do not have the resources to do all we would like to beautify the City so I want to thank the Del Rey Oaks Citizen's Action Group (CAG) and various volunteer groups for their efforts to beautify our City. This Adopt-an-Island program has resulted in the adoption and beautification of public spaces such as our traffic islands and the results are fantastic. Take a look at the kiosk and island at Rosita and Angelus. The pride shows. Some of the volunteers are from our new partner unit from the Defense Language Institute, so I'd like to thank the young airmen of the 314th Training Squadron for their help. If you are interested in adopting an island please contact City Hall or the Citizen's Action Group for more information. Finally, an aspiring Eagle Scout completed his project to replace damaged timbers on the tables in our park, clear trails, and install owl boxes in the woods surrounding the park. City leadership attended his Court of Honor as he earned his Eagle Scout rank, in part by helping beautify our City.

Your City staff continue to reach out in various ways to share information and listen to residents. The City will hold its next Open House in Old Town Hall this June. We continue to post notices of events or public service notices online, and we have started a monthly coffee with the City Manager that moves from business to business and varies times to allow residents with various schedules to attend if they choose. I thoroughly enjoy speaking with all of you and hearing your concerns.

Your City staff is heavily engaged with the Fort Ord Reuse Authority to install the public infrastructure on our Fort Ord parcel to allow for future development. These infrastructure projects include the construction of South Boundary Road, and the extension of power, sewer, and water utilities down South Boundary. We will keep the public informed of progress.

The City's revenue outlook has never been better. We anticipate ending Fiscal Year 2017-2018 with a balance that Council can dedicate to an economic uncertainty reserve and pay down City debt. This will happen as we continue to make important and long overdue investments in roads, parks, and public safety. While our revenue outlook is healthier than ever, it is largely based on cannabis tax, which is a dynamic and volatile sector of the economy. Therefore, your City Staff continues to develop and diversity revenue streams to provide for the long-term economic stability of Del Rey Oaks.

I want to thank our small dedicated City Staff of three non-public safety employees and six police officers. Pound for pound, no City team delivers what this team delivers, and I am honored to lead them. I also want to thank all of you who selflessly volunteer your time to serve, whether on Council, Planning Commission, the CAG or in various ways helping beautify our City and put on wonderful events. It is a pleasure to serve our community!

Radar Signs Installed on Portola Drive

An interesting statistic from the Police Department: The majority of drivers caught speeding are Del Rey Oaks residents not people passing through the City to their destinations.

Please follow the speed limit and keep all of our streets safe for children, pets, walkers, cyclists and other drivers. Plan ahead for the additional minute or two that it will take to simply go the speed limit.

The Police Department patrols all of the city streets repeatedly day and night but we can't be everywhere at once, so please help us by reducing your speed.

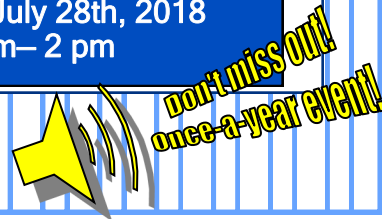

Using Grants to Better Your City

Some cities have lots of retail businesses that supply millions of tax dollars to keep their city governments running. Del Rey Oaks isn't one of those. We have more residents than businesses and that's the way we like it. So when it comes time to replace a vehicle or piece of equipment we have to find the money to accomplish that. That's where grants come in.

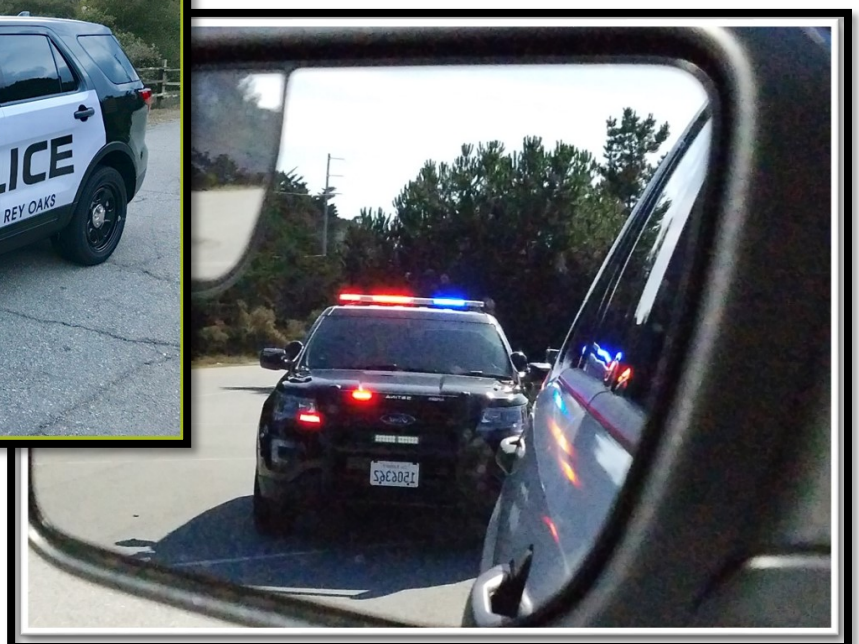
We apply for grants from many different agencies for many different reasons. One of those is the Fort Ord Reuse Authority Caretaker Grant. This money is available to purchase equipment and to pay for services directly related to our former Fort Ord property which is only accessible with 4 wheel drive vehicles and equipment.

During fiscal years 2016-2017 and 2017-2018 we applied to purchase two 2017 Ford Interceptor SUVs for our police department, a heavy duty tractor, a powerful wood chipper, replacement fencing and Gabilan Crew services used for roadside cleanup along South Boundary Road and on our Fort Ord property. We were awarded funding for all of these things.

Below you will see pictures of one of the two SUVs painted in our new more updated design. Of course you never want to see them from the point of view in the second picture. So as a reminder from the Police Department remember to never pass on the right into a bike lane, even if you see someone else do it first.

On the next page you will see our "new" tractor. Our public works manager found this used tractor for an excellent price. It has low use hours and is built to be used for larger jobs. It replaces a small garden style tractor that could not handle the types of projects we needed it for on the Fort Ord property. This new tractor came with lots of attachments that have already come in very handy from removing debris to digging up tree roots for our future slurry seal project mentioned early in this edition.

Also on the next page is the "new" wood chipper purchased. Again our public works found this used chipper for an amazing price and we've already used it to chip up all the brush and tree trimmings from South Boundary Road with our last cleanup using the Gabilan Crew. This has saved us thousands of dollars in rental



costs since we've been renting a chipper every time we have a big job to do.

We don't take these grant funds lightly. We buy good quality equipment and services that will last and we use every bit of it to help make Del Rey Oaks the best little city on the peninsula. You can see more grant money at work on Pages 12 and 14.

Transportation Agency for Monterey County (TAMC) Canyon Del Rey Blvd (SR-218) Corridor Study

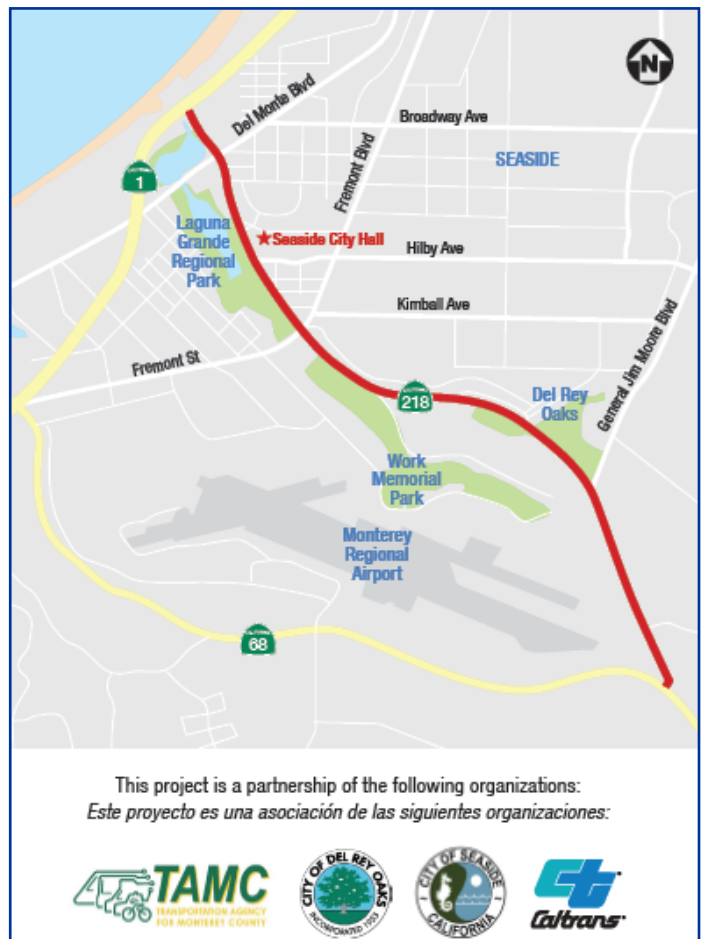
Project Background

The Transportation Agency for Monterey County (TAMC) is leading the Canyon Del Rey Boulevard (State Route 218) Corridor Study in partnership with the cities of Del Rey Oaks, Seaside and Caltrans. The Corridor Study will gather data, conduct a technical traffic forecast analysis, and utilize public input to identify a set of complete streets, stormwater drainage, active transportation, and environmental and wildlife preservation improvements for Canyon Del Rey Blvd from Highway 1 to Highway 68.

Corridor Study Goals

Make Canyon Del Rey Boulevard safer for different forms of transportation and for people of all ages and abilities

- Document existing conditions
- Engage local residents and regional partners in the study process
- Recommend complete street improvements including:
 - Sidewalks, street furniture, lighting and plantings; intersection improvements for safe, accessible pedestrian crossings; bus transit improvements along the corridor; bicycle lanes, paths and/or signage, including connections to existing and planned projects, such as the City of Monterey’s North Fremont Street bike and pedestrian improvements and the planned Fort Ord Regional Trail & Greenway.
- Recommend conceptual designs for drainage and underground utility improvements, including “Green Street” improvements
- Recommend priorities and phasing for implementing improvements



- Identify potential fund sources for implementation

Project Funding

- \$150,960 Caltrans Strategic Partnerships Planning grant
- State Rural Planning Assistance funds and local funds totaling \$63,811 are budgeted as matching funds
- Total project cost is estimated to be \$214,771, including \$133,800 cost for the consultant portion of this study

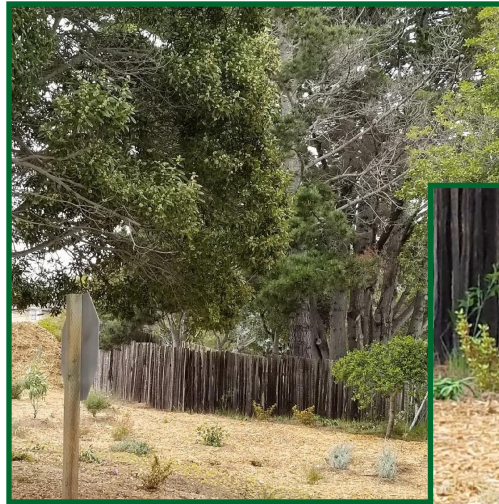


Transportation Agency for Monterey County (TAMC) Bicycle Secure Grant Program
