PARK HOURS: Dawn to Dusk

- ALCOHOLIC BEVERAGES ARE PROHIBITED ON THE PARK GROUNDS 12.20. MC
- FIREWORKS ARE PROHIBITED WITHIN THE CITY 12.20.070 (2)(B) MC
- NO DOGS OFF LEASH ARE ALLOWED OUTSIDE DOG PARK AREA 12.20.070(2)(C) MC
- CLEATS OR SPIKED SHOES ARE NOT ALLOWED IN PARK 12.20.060(D)(2) MC
- DO NOT USE STAPLES OR TACKS WHEN SECURING TABLE COVERINGS, PLEASE USE TAPE
- PLEASE USE THE RECYCLE CONTAINERS FOR GLASS, ALUMINUM & PLASTIC MATERIALS ONLY
- DISPOSE OF ANY OTHER LITTER PROPERLY AND BAG UP EXTRA TO TAKE WITH YOU

NOISE CONTROL:

TEMPORARY DAY USE PERMIT:

For use of portable recreational structures (JUMP/BOUNCE HOUSES), tents, canopies, etc., a Temporary Day Use Permit (\$50.00 fee), is required. Embedding stakes or poles into the ground is prohibited. 12.20.030 (A)(4) MC All jump/bounce houses must be run by generator - no electricity in park.

BARBEQUE AREAS:

Reservations are required for use of large brick barbeque pits.
