**PARK HOURS:** Dawn to Dusk

- < **ALCOHOLIC BEVERAGES ARE PROHIBITED ON THE PARK GROUNDS** 12.20. MC
- < **FIREWORKS ARE PROHIBITED ON THE PARK GROUNDS** 12.20.070 (2)(B) MC
- < **NO DOGS ALLOWED OUTSIDE DOG PARK AREA** 12.20.070(2)(C) MC
- < **CLEATS OR SPIKED SHOES ARE NOT ALLOWED IN PARK** 12.20.060(D)(2) MC
- < **DO NOT USE STAPLES OR TACKS WHEN SECURING TABLE COVERINGS, USE TAPE**
- < **PLEASE USE THE RECYCLE CONTAINERS FOR GLASS, ALUMINUM & PLASTIC MATERIALS ONLY**
- < **DISPOSE OF ANY OTHER LITTER PROPERLY**
- < **RESTROOMS ARE YOUR RESPONSIBILITY YOU WILL BE CHARGED FOR ANY DAMAGE OR VANDALISM THAT OCCURS DURING YOUR RENTAL PERIOD. IF YOU NOTICE ANYTHING BEFORE OR DURING YOUR RENTAL PERIOD CALL 375-8525 AND REQUEST ASSISTANCE.**

**NOISE CONTROL:**

To operate any loudspeaker system, or amplification device including a boom box, prior authorization must be obtained and noted in writing on the reservation from the Chief of Police. 8.20.010 MC

**PARKING:**

Park in designated spaces only. **Vehicles are prohibited on the park grounds.** Please tell your bounce house vendors **NOT** to drive on the grass. 12.20.050(F)(1)MC Parallel park only along Park East, **do not** block access road.

\_\_\_\_\_ *INITIAL*

**TEMPORARY DAY USE PERMIT:**

For use of portable recreational structures (*JUMP/BOUNCE HOUSES*), tents, canopies, etc., a Temporary Day Use Permit (\$50.00 fee), is required. Embedding stakes or poles into the ground is prohibited. 12.20.030 (A)(4) MC **All jump/bounce houses must be run by generator - no electric in park.**

**BARBEQUE AREAS:**

- < Reservations are required for use of large brick barbeque pits. If you arrive prior to your reservation time and the barbeque is locked, contact a Police Officer by use of the yellow phone at the entrance to City Hall or by calling DROPD Dispatch at **375-8525**.
- < Personal barbeques's are not permitted in park

**CANCELLATIONS & REFUNDS:**

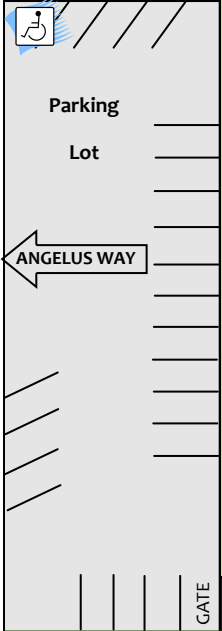
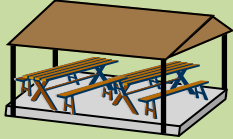
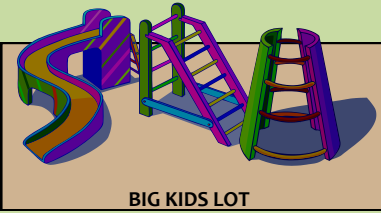
- < **72 hour notice** prior to your event is required. Contact Del Rey Oaks City Hall at 394-8511 (*Monday through Friday 8:00 am - 5:00 pm*)
- < If the reservation is not used due to rain (*Saturday or Sunday*), you must contact the Del Rey Oaks Police Department at 394-9333 or 375-8525, the morning of the reservation. The following Monday contact City Hall at 394-8511, your money will be refunded only if the Del Rey Oaks Police Department received your notification and it rained during your scheduled time slot.

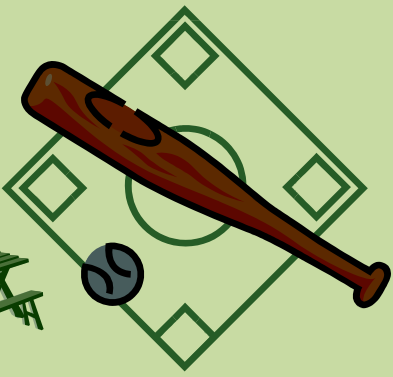
**AN EMERGENCY TELEPHONE (YELLOW PHONE) IS LOCATED NEAR THE
